Call to order (12:30pm)

Russ Bowen, BoT President, calls meeting to order. He welcomes all and announces a quorum is present.

Chalice Lighting and Opening Reading

Russ Bowen gives opening reading while Jenny Warnasch, Past Board President, lights chalice.

Russ Bowen introduces members the BoT and the Building Task Force.

Russ Bowen displays Congregational Covenant and reads aloud.

20190201: Awaiting Approval

Andy Hencke, Board Member at Large, announces that the Close the Gap Committee has been approved. He then presents the Strategy for Closing Gap (slides) and affirms that there is a plan. (12:39)

Andrew Wright explains how this plan is to be approved (slides) and that there is congregational action required in order to move this plan forward. (12:41)

Reading of Motion (12:42)

Russ Bowen displays the motion (slide) and reads aloud. He then invites the congregation to discuss.

A congregants asks if the previous loan has been paid off. Andrew Wright confirms that it has been. Another congregants ask if this plan accounts for the loss of revenue from the preschool. A. Wright confirms that it has been taken into account. A congregants asks if pledges can be paid early. A. Wright encourages this. The same congregants asks what happens if members haven't fulfilled pledges yet. A. Wright explains that there is a follow-up procedure in place. Another congregants asks about new members participation in funding the gap. A. Hencke explains that there is a Task Force dedicated to that purpose. Rev. Thom Belote provides further explanation to new members present.
